

Clean and Green (and blue!) 27 Local Elementary Schools Received New Recycling Dumpsters from Burlington County

Students and staff at Burlington City's Wilbur Watts Intermediate School may have recently noticed something different behind their school building.

Gone is an old, faded teal recycling dumpster riddled with rust. In its place is a new, shiny one adorned with large signs reminding users to flatten cardboard and to keep trash, Styrofoam, plastic wrap and plastic bags out.

The upgraded dumpster was provided by the Burlington County Department of Solid Waste and Recycling, which periodically offers new dumpsters for local school districts to replace deteriorated or damaged ones.

It may seem like a small change, but it is an important one, according to Burlington County Commissioner Deputy Director Allison Eckel.

"Recycling is key for protecting our environment and keeping our communities clean and safe," said Eckel, the board liaison to schools. "Having a new well labeled, recycling dumpster

reinforces the message that recycling is important and is something students and staff can take pride in."

Commissioner's Message:

Burlington County's Switch to Single-Stream Sorting Was a Gamechanger for Recycling



Hello friends and welcome to Burlington County's recycling guide.

It was just over 40 years ago that Burlington County launched its regional recycling program, and it continues to grow and evolve with the times. The service began in the early 1980s with newspaper collections but has steadily grown to include all varieties of paper, steel and aluminum cans, glass bottles and jars, and certain plastics.

One of the biggest changes came ten years ago, in 2015, when Burlington County switched to a single-stream recycling system.

Before single-stream, residents had to separate their paper and cardboard recyclables from aluminum, glass and plastics. Single-stream allowed us to accept glass and plastic containers, cans, paper, and cardboard in the same container.

Single-stream was a significant change that required a large investment to retrofit the County's recycling plant in Westampton with new state-of-the-art equipment capable of sorting the different materials, including the ability to sort over 450,000 bottles and cans each day. Ultimately, it proved to be a gamechanger for the County's recycling program, dramatically increasing participation and reducing the volume of waste disposed in our landfill.

While sorting at the recycling plant is now largely automated, the County still depends on workers from OTC Services (previously named the Occupational Training Center) to collect recycling from across the county. OTC workers also help sort recyclables and operate the plant and its machinery.

While recycling at home is much simpler because of the decade-old change, we still rely on our residents to be diligent about what they put into curbside recycling containers. Recycling the wrong items can clog or damage the plant's equipment or spark potentially devastating fires. Dirty cardboard, plastic and glass can also contaminate recycling bales and cause recycling companies to reject them.

This guide can be a useful resource to help you and your family recycle the right things correctly.

In total, 27 dumpsters were replaced in elementary and middle schools. Later this year, the County will offer new ones to local high schools.

To receive a new recycling dumpster, schools needed to apply to the Department of Solid Waste and Recycling and provide a photo of their existing dumpster to demonstrate the need for replacement.

All new dumpster requests received in 2024 were fulfilled using \$32,000 of the County's annual recycling grant from the New Jersey Department of Environmental Protection.

"Typically, these dumpsters run around \$1,200 each, so using our grant funding for

this purpose provides a small savings to schools and taxpayers," said Eckel.

and services all public schools in the county, along with nine private schools and all Rowan College at Burlington County sites.

Last year, more than 840,000 pounds of recyclables from 155 school facilities was collected.

"That amounts to 422 tons of material schools kept out of the landfill and approximately \$42,000 in savings from landfill tipping fees," said Commissioner Tom Pullion, liaison to the Department of Solid Waste and Recycling. "It's a great service that promotes good recycling habits in schools and at home."

The Sustainable Living, Recycling, and Clean Communities tents will feature displays, games and collection bins for plastic bags/film, reusable bags and small e-waste items like ear buds, cell phones and power cords.

New to the Fair will be a special bicycle collection by the Mercer County Boys and Girls Club. The club collects unwanted bikes, making minor repairs as needed, and donates them to residents in need.

How to Prepare Your Recyclables



Recyclables should be clean, dry, and empty.



NEVER bag recyclables. Place them loose in vour cart.



Recycling should be at the curb by 6am on collection day.



Cardboard must be emptied, flattened, folded and placed in recycling container or stacked neatly and loosely next to it.

Pizza Box Guidelines

Pizza boxes must be clean and empty. A **small** amount of grease is okay.


Battery Fires Present One of the Biggest Challenges to the Recycling and Waste Industry

Lithium-ion batteries are everywhere – from smartphones and smartwatches to wireless headphones, car key fobs, remote controls, toys, e-bikes, power tools, and even singing greeting cards. Lightweight and long-lasting, they've become an essential part of daily life.

Here's the catch: When these batteries end up in recycling trucks or facilities, they pose a serious hazard. Never put batteries in recycling. A minor spark can rapidly escalate into a dangerous fire, threatening workers, equipment, and the entire facility. This risk is

caused by a process known as thermal runaway. When the battery is crushed, punctured, or overheats, it can generate so much heat that it ignites itself – causing the battery to leak, swell, or burst into flames.

The fire risk is real and on the rise. Improperly discarded lithium-ion batteries resulted in a fire on one of our recycling trucks (pictured right). We've also had three battery-caused fires at our recycling center in just the past six months. Thankfully, all were detected and extinguished before causing any damage.



Trex Plastic Recycling Challenge Groups Collect Over 64,000 Pounds!

Plastic bags and film, such as shipping mailers, bubble wrap, beverage and paper goods case wrap, and bread bags cannot be put in curbside recycling because they jam sorting equipment. Volunteer groups (schools, civic groups, scouts, sports groups, corporate green teams, etc.) can help keep plastic bags and film out of our landfill by taking the Trex Company's Recycling Challenge.

Trex uses these separately collected clean and dry plastics to make outdoor decking and furniture. Groups that collect and deliver 1,000 lbs. of Trex plastic bags and film to a collection center will win a handsome Trex bench from recycled plastic.

In 2022, the Burlington County Commissioners set up a drop off site for plastic bags and film at the Robert C. Shinn Jr. Recycling Center (OTC) in Westampton to give Trex Challenge groups a convenient spot to drop off their plastics. To date, dozens of organizations have delivered over 64,000 lbs. of plastic bags and film to the Center. Some groups, like the Medford Green Team, have earned multiple benches for their township's parks.

"Thanks to the dedicated band of volunteers, the equivalent of over 5 million pounds of plastic bags



were kept out of our landfill" said Commissioner Tom Pullion, liaison to the Department of Solid Waste and Recycling. "Our county is certainly cleaner and greener due to their efforts."

Trex Challenge Program Details:

- Register your group at NexTrex.com and select a plastic recycling partner (the County Recycling Center is listed as "OTC").
- Trex provides groups with 3 collection bins.
- Collect a minimum of 1,000 lbs.
- Weigh, record and attach pictures at my.trex.com.
- Deliver bags of plastic to the County Recycling Center (listed as OTC on the Trex site). Acme, Kohls, Wegmans, and Whole Foods may also take them. When you reach your goal, Trex will ship your bench!

In 2018, the N.J. Department of Environmental Protection launched Recycle Coach, a **free** app designed to give residents easy access to local recycling information.


Today, over 35,500 Burlington County residents use the app on their mobile phones or computers. Unsure what your recycling day is or where to recycle an old TV? The app has the


Clean Communities County Road Litter Cleanup Results with OTC Litter Crew

In 2024, the OTC Road Litter Crew worked 3,003 hours to collect approximately 82,145* pounds of litter on 319 miles of county roadways during 183 cleanup days.

Steps You Can Take to Help Prevent Stormwater Pollution



Litter and leaves can clog storm drains, causing rainwater to back up onto your property and into your home. Debris that washes into a storm drain can travel underground through pipes and come out into lakes, rivers, streams and even the ocean. Litter can attract rodents and disease, posing a health risk; litter also poses a risk to animals and marine life.

Never dump anything into the storm drain!

Don't use a hose to wash contaminants such as oil spills or antifreeze off your driveway. Do not drain your pool, spa, or fountain water into the storm drain, and don't over-water chemically treated lawns and gardens.

What CAN you do? Adopt the storm drain near your home by volunteering to regularly inspect it and keep it clean. Remove litter from your property and street, even if it is not yours. Make sure your recycling bins don't overflow. If your recyclables fall out of the bin, pick them back up. Encourage your neighbors to keep their storm drains clean.


